Eligibility	Claims are only open to residents of Australia. Each claimant is restricted to a maximum one (1) Gift (Claimants). Directors, management and employees (and each of their Immediate family members) of the Promoter and its contractors and agencies associated with the Offer are ineligible to claim. "Immediate family members" means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

Offer Period	The offer period starts at 8.00am AEST on Monday 24 August 2026 and closes at 11:59pm AEST on Sunday 6 September 2026, while stocks last (Offer Period). CONDITIONS OF CLAIM

CLAIM

1. Offer not valid in conjunction with any other offer, promotion or discount, unless stated otherwise.
2. Any costs associated with accessing the Participating Channel to enter the promotion and claim a gift are the claimant's responsibility and is dependent on the Internet service provider used. The Co-Promoters is not responsible for any costs incurred by claimants associated with entering the Offer including any purchases required to enter the promotion.
3. The use of any automated entry software or any other mechanical or electronic means that allows a claimant to automatically enter repeatedly is prohibited and will render all claims submitted by that claimant invalid.

16. 21. The Co-Promoters reserve the right, at any time, to verify the validity of claims (including verifying the purchase made via the Participating Channel within the required timeframe) and claimants (including a claimant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Co-Promoters has reason to believe has breached any of these Terms and Conditions (including without limitation, bulk or commercial purchasers), tampered with the claim process or engaged in any unlawful or other improper misconduct

calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Co-Promoter's discretion. Failure by the Co-Promoters to enforce any of its rights at any stage does not constitute a waiver of those rights. The Co-Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

23. 24. any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.

PRIVACY

27. The Co-Promoters collects personal information (PI) in order to conduct the Offer and may, for this purpose, disclose such PI to third parties, including but not limited to related entities, agents, contractors, service providers, event organizers, gift suppliers and, as required, to Australian regulatory authorities. 28. The Promoter may, for an indefinite period, unless otherwise advised, use the PI for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the claimants.
29. The Privacy Policy also contains information about how claimants may opt out, access, update or correct their PI, how claimants may complain about a breach of the Australian Privacy Principles or any other applicable law and how those complaints will be dealt with.
30. All claims become the property of the Promoter. The Promoter may disclose claimants' PI to selected entities outside of Australia (see the Promoter's Privacy Policy for details).

SOCIAL MEDIA

31. Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the *Competition and Consumer Act 2010* (Cth), as well as any other implied warranties under the *Australian Securities and Investments Commission Act 2001* (Cth) or similar consumer protection laws in the States and Territories of Australia (**Non-Excludable Guarantees**). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.
35. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or gift claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in gift value to that stated in these

Terms and conditions; (e) any tax liability incurred by a claimant; or (f) use of the gift(s).
