

Conditions of entry



Venue Child Policy

Children under the age of 14 are required to be accompanied by an adult at all times.

For the comfort, safety and enjoyment of all patrons, please note the following:

Entry to the Bowl of Brooklands is based on full agreement to these Conditions of Entry. Accordingly, **please read them carefully and do not enter** the Bowl of Brooklands if you do not agree with any of the conditions of entry. Management reserves the right to refuse entry to any persons.

The Event will proceed rain, hail or shine and will only be abandoned if the Promoter, Venue Management (NPDC) and emergency services representatives deem the conditions to be dangerous.

Management reserves the right to inspect any bag and/or articles of clothing if the situation demands it. Refusal to present any item for searching will result in refusal of entry. Security may use wandings with metal detectors at each gate.

No bags bigger than an A4 size can enter (dimensions: 30cm wide x 21cm x 21cm) the venue due to international security rules.

All bags will be searched and any confiscated items will not be returned, replaced or reimbursed. Management and the promoter take no responsibility for confiscated items. This event complies with the Liquor Licencing Authority and prohibits the serving of alcohol to intoxicated or under-aged persons.

The following items are prohibited from being brought into the venue:

- Alcohol and/or illicit drugs
- Commercial takeaway food such as Pizza Hut, KFC, McDonalds, Burger King etc.
- Glass of any kind
- Outdoor furniture (this includes beanbags and deck chairs), however low sand chairs may be brought into the general admission area for this event. Please ensure they are foldable or compact. No low sand chairs in the premium standing or lake platform areas.
- Pushchairs and strollers
- Umbrellas
- Cameras with detachable lenses and/or tripods, video cameras, audio recording or any other equipment deemed by the Promoter to be *professional* in nature.
- Drinks, cans, glass or thermos (sealed and clear, or empty plastic water bottles up to 750ml are permitted and can be refilled at the water stations on site)
- Metal utensils and containers, sharp cutlery, etc.
- Chilly bins and coolers
- Banners with poles
- Musical instruments, air horns, megaphones, drums etc.
- Fireworks, laser lights, laser pointers, flares or distress signals
- Gang patches and gang colours
- Weapons or any object that may be used as a projectile, knives, tasers, Mace, chains, spurs, or studded jewellery
- Illegal substances and items or dangerous goods
- Rollerblades/skates/skateboards/scooters
- Animals other than accredited service animals
- Unauthorized signage and promotional products
- Aerosol cans
- Other items that could cause harm or public nuisance as determined by Venue Management (NPDC)

Please note the follow conditions applicable to this event:

- Alcoholic beverages must not be taken into or out of the Bowl of Brooklands.
- Entry will be refused to any person who is intoxicated or under the influence of illicit drugs. Intoxicated persons will be escorted from the venue premises and incidents involving alcohol or drugs will be referred to the NZ Police where the situation requires it.
- Under-aged persons who are apprehended with alcohol will be escorted from the premises and any persons supplying alcohol to under-aged patrons will be evicted from the premises.
- Guests must not enter the lake at any time. Any that do will be removed from the venue.
- Guests bringing personal belongings into the Bowl of Brooklands do so at their own risk.
- No coat check or cloak room facilities will be provided at this event.
- Guests must not climb, deface, post or stick any bills or advertisement on or otherwise damage or misuse any structure, building, wall or fence at the venue.
- Guests must refrain from littering, offering for sale any goods or services, blocking any thoroughfare, throwing objects or behaving in a disruptive or offensive manner.
- Guests causing disturbance or failing to comply with these conditions of entry or requests from staff or Police may be removed from Bowl of Brooklands. If removed, it is an offence to attempt re-entering the venue for the remainder of the event.
- No ticket refunds or exchanges will be provided.
- Guests must show a valid identification card as proof of eligibility if they wish to purchase any alcoholic beverage. This event complies with the Liquor Authority and prohibits the serving of alcohol to intoxicated or under aged persons. In New Zealand the following are the only accepted forms of ID:
- A valid passport - New Zealand Driver's License - HANZ 18+ card - Kiwi Access Card
- Guests enter the Bowl of Brooklands at their own risk. To the extent permitted by law, you irrevocably release and discharge Management from all liability to claims, losses, damages, costs and expenses (whether arising under statute, from negligence, personal injury, property damage or otherwise) arising from or in connection with your attendance at Bowl of Brooklands.
- Guests may be filmed, recorded or photographed during the event and these images or recordings may be used for any purpose without the consent of, or payment or provision of other compensation.
- Entry may be refused if the ticket was purchased from an unauthorised ticket seller or ticket scalper. Defaced tickets will not be accepted.
- The Bowl of Brooklands and surrounding Pukekura Park are non-smoking venues. This includes vaping and e-cigarettes.
- No pass-outs will be permitted for this event.

The following items are permitted in the venue:

- Sealed, clear plastic drink bottles (up to 750ml)
- Empty plastic drink bottles (up to 750ml) to use at the water stations
- Small quantities of homemade food allowed, so long as it fits in a small carry bag which is no bigger than A4 size
- Low sand chairs which are compact/foldable (in general admission only – not on the terrace or platform).

In extreme cases, a patron who exhibits unacceptable or disruptive behaviour will be asked to leave the venue. Dangerous activities such as aggressive moshing, stage diving, crowd surfing and climbing are not permitted and may result in the removal of guests from the event. Failure to comply with a direction from staff, security or the NZ Police to leave the venue after having being warned to leave may render the ticket holder liable to arrest and prosecution for the offence of trespass (under section 4 of the Trespass Act 1980) which is punishable on conviction by a fine not exceeding \$1000 or a term of imprisonment not exceeding 3 months.
