# **Conditions of entry**

#### **Venue Child Policy**

Children under the age of 14 are required to be accompanied by an adult at all times.

### For the comfort, safety and enjoyment of all patrons, please note the following:



Entry to the TSB Bowl of Brooklands is based on full agreement to these Conditions of Entry. Accordingly, **please read them carefully and do not enter** TSB Bowl of Brooklands if you do not agree with any of the conditions of entry. Management reserves the right to refuse entry to any persons.

The Event will proceed rain, hail or shine and will only be abandoned if the Promoter, Venue Management (NPDC) and emergency services representatives deem the conditions to be dangerous.

Management reserves the right to inspect any bag and/or articles of clothing if the situation demands it. Refusal to present any item for searching will result in refusal of entry. Security may pat down and or wanding with metal detectors at each gate.

Bags no bigger than an A4 size allowed into the venue due to international security rules.

**Bags will be searched.** Confiscated items will not be returned, replaced or reimbursed. Management and the promoter take no responsibility for confiscated items. This event complies with the Liquor Licencing Authority and prohibits the serving of alcohol to intoxicated or under aged persons

#### The following items are **prohibited** from being brought into the venue:

- Alcohol and/or illicit drugs
- Commercially bought food such as Pizza Hut, KFC, McDonalds, Burger King etc.
- No glass to be brought into the venue
- All chairs including low chairs/outdoor furniture / air loungers / beanbags
- Pushchairs and strollers
- Umbrellas
- Cameras with detachable lenses and/or tripods, video cameras and audio recording equipment or any other equipment deemed by the Promoter to be *professional* in nature.
- Banners with poles
- Drinks, cans, glass or thermos (sealed and clear, or empty plastic water bottles up to 750ml are permitted)
- Metal utensils and containers, sharp cutlery, etc.
- Chilly bins/coolers
- Dangerous goods
- Musical instruments, air horns, megaphones, drums etc.
- Fireworks / Laser lights / Laser pointers
- Gang patches / Gang colours
- Weapons / Any object that may be used as a projectile / Knives, Tasers, Mace, Chains, Spurs, or Studded jewellery
- Flares/distress signals
- Illegal substances/items
- Rollerblades/skates/skateboards/scooters
- Animals other than service animals (Guide Dogs etc. are welcome)
- Unauthorized signage and promotional products
- Aerosol cans
- Other items that could cause harm or public nuisance as determined by Venue Management (NPDC)
- 1. Alcoholic beverages must not be taken into or out of the TSB Bowl of Brooklands.
- 2. Entry will be refused to any person who is intoxicated or under the influence of illicit drugs.
- 3. Intoxicated patrons will be escorted from the venue.
- 4. Incidents involving alcohol or drugs will be referred to the NZ Police where the situation requires it.
- 5. Under-aged persons who are apprehend with alcohol will be escorted from the premises
- 6. Persons supplying alcohol to under-aged patrons will be evicted from the premises
- 7. Patrons must not enter the lake at any time (if they do so they will be removed from the venue).
- 8. Patrons bringing personal belongings into the TSB Bowl of Brooklands do so at their own risk.
- 9. No coat check or cloak room facilities will be provided at this event.
- 10. Patrons must not climb, deface, post or stick any bills or advertisement on or otherwise damage or misuse any structure, building, wall or fence at the TSB Bowl of Brooklands.
- 11. Patrons must refrain from littering, offering for sale any goods or services, blocking any thoroughfare, throwing any object, behaving in a disruptive or offensive manner.
- 12. Patrons causing disturbance or failing to comply with these conditions of entry or requests from staff or Police may be removed from TSB Bowl of Brooklands. If removed, it is an offence to enter, re-enter or attempt to re-enter to venue for the remainder of this event.
- 13. No ticket refunds or exchanges will be provided.
- 14. Patrons must show a valid identification card as proof of eligibility if they wish to purchase any alcoholic beverage. This event complies with the Liquor Authority and prohibits the serving of alcohol to intoxicated or under aged persons, In New Zealand the following are only accepted forms of ID:
  - A valid passport New Zealand Driver's License HANZ 18+ card
- 15. Patrons enter the TSB Bowl of Brooklands at their own risk. To the extent permitted by law, you irrevocably release and discharge Management from all liability to claims, losses, damages, costs and expenses (whether arising under statute, from negligence, personal injury, property damage or otherwise) arising from or in connection with your attendance at TSB Bowl of Brooklands.
- 16. Patrons may be filmed, recorded or photographed during the event and these images or recordings may be used for any purpose without the consent of, or payment or provision of other compensation to patrons.
- 17. Entry may be refused if the ticket was purchased from an unauthorised ticket seller or ticket scalper. Defaced tickets will not be accepted. Even if proof of purchase is provided, lost or stolen tickets will not be replaced or reissued. Your ticket is your responsibility.
- 18. The TSB Bowl of Brooklands and surrounding Pukekura Park are non-smoking venues.
- 19. No pass-outs will be permitted for this event.

## The following items are **permitted** in the venue:

- Small personal cameras and camera phone are allowed
- Empty plastic bottles without a lid (up to 750ml) to use at the water stations
- Sealed and clear bottles of water (up to 750 ml)
- Small quantities of homemade food allowed as long as it fits in a small carry bag.

In extreme cases, a patron who exhibits unacceptable or disruptive behaviour will be asked to leave the venue. Dangerous activities such and aggressive moshing, stage diving, crowd surfing and climbing are not permitted and may result in the removal of patrons from the event. Failure to comply with a direction from staff, security staff or the NZ Police to leave the event venue after having being warned to leave may render the ticket holder liable to arrest and prosecution for the offence of trespass under section 4 of the Trespass Act 1980 which is punishable on conviction by a fine not exceeding \$1000 or a term of imprisonment not exceeding 3 months.
